

## **Information clause on the investment of phase I of F.S.O. PARK**

### **Who is the Controller of your data?**

The administrator of your personal data is OKAM Capital Ltd. Based in Warsaw, 88 Jagiellońska street, 03-215 Warsaw (hereinafter referred to as the "Administrator"), and joint data controllers are entities related to the Administrator by capital or personal means.

### **Why do we process your data?**

Personal data is obtained by the Administrator as a result of you completing the online contact form at <https://fso-park.pl/dialog/> for the purpose of submitting questions and expressing comments and opinions as part of the dialogue on the investment of phase I of F.S.O. PARK to inform the general public about the planned submission of an application for the location of a residential investment and an accompanying investment at 88 Jagiellońska street in Warsaw (hereinafter referred to as the "Investment") and to present the concept of the Investment, as well as for a conversation about it, which will be included in the dialogue report about investment.

### **What data do we process?**

Your personal data will be processed for the purposes of:

- conducting the investment dialogue process referred to in the section "Why do we process your data", including collecting, recording and processing questions, comments and opinions regarding the Investment,
- moderation of comments, in particular content that is vulgar, offensive, aggressive, persecutory towards other people, promoting violence, hatred towards groups of residents and containing threats of harm,

- involving the determination, investigation or defense against possible claims

(legal basis: art. 6 ust. 1 pkt. f) RODO – legitimate interest of the Administrator).

### **How long do we process your data?**

Your personal data will be processed for the period necessary to achieve the processing purposes specified in the section "What data do we process", i.e. for the period of the investment dialogue process or until you raise an objection to data processing resulting in the obligation to take it into account, as well as for the period and to the extent necessary to establish, pursue or defend against possible claims.

### **Who do we share your personal data with?**

Your personal data will be transferred to the following recipients: entities related to the Administrator by capital or person, persons authorized to process personal data on the basis of an entrustment agreement concluded with the Administrator (including entities cooperating with the Administrator: entities providing IT services, legal or advisory services, marketing services).

### **What are your rights?**

You have the right to access your data and the right to rectify, delete, limit processing, the right to transfer data, and the right to object to the processing of your personal data. The detailed scope of each of the above-mentioned rights and the situations in which you can exercise them are indicated in art. 15-22 RODO.

You have the right to lodge a complaint with the supervisory authority if you believe that the processing of your personal data violates applicable provisions on the protection of personal data.

You have the right to request from the Administrator. access to your personal data, as well as to request their rectification, deletion, restriction of processing, transfer and to object to their processing.

**Can you withdraw your consent?**

You may withdraw your consent at any time by contacting the Personal Data Protection Representative, and the withdrawal of consent does not affect the compliance with the right to processing carried out before its withdrawal.

**Is providing your data mandatory?**

Providing your data is voluntary, but necessary to achieve the goal - placing and handling comments on the website <https://fso-park.pl/dialog/>.

**Do we process your personal data automatically, including through profiling?**

Your personal data may be processed automatically, but will not be profiled.
